could be considered as the violation of the Communicable Diseases Act B.E. 2558.

The company shall conduct health screening, in compliance with the guidelines of

Department of Disease Control, at the meeting entrance. For those being identified

with respiratory symptom, the company reserves the right to deny entry into the

meeting room. (In case that the aforementioned shareholder presents at the venue,

such shareholder may grant a proxy to an Independent Director to attend the

meeting).

The company will assign a seat with appropriate social distancing for attendees by

the guideline of Ministry of Health.

Every attendee must wear a facemask for the duration of time in the meeting room.
